MEMORANDUM OF UNDERSTANDING (MOU) UNDER THE FRAMEWORK OF THE 'AI4GLOBE' INITIATIVE, BETWEEN LLC 'BUSINESS AND TECHNOLOGY UNIVERSITY' (BTU, GEORGIA)

AND NIZHYN MYKOLA GOGOL STATE UNIVERSITY (NMGSU, UKRAINE) . TO PROMOTE AI LITERACY GLOBALLY.

1. PURPOSE

This Memorandum of Understanding (MoU) establishes a collaborative framework between LLC "Business and Technology University" (BTU, Georgia), address: 82, Ilia Chavchavadze Avenue, 0162 and Nizhyn Mykola Gogol State University (NMGSU, Ukraine), address: 2 Grafska Str., 16600, Nizhyn to jointly promote artificial intelligence (AI) literacy through the AI4Globe initiative. The initiative aims to enhance understanding and utilization of artificial intelligence across various demographics, including academia, business, women, children and youth.

2. OBJECTIVES

The objectives of this MoU are to:

- 2.1. Collaborate on the development and implementation of educational programs focused on AI literacy.
- 2.2. Facilitate the effective dissemination and utilization of AI4Globe resources created by BTU.
- 2.3. Encourage collaborative efforts in promoting AI literacy through workshops, training programs, and educational materials.
- 2.4. Support partners in implementing resources developed under the AI4Globe initiative within their own educational and training contexts.
- 2.5. Foster a global network of stakeholders committed to advancing AI understanding and application.

3. ROLES AND RESPONSIBILITIES

3.1 LLC "Business and Technology University" (BTU) will aim to:

- 3.1.1. Make available resources, educational materials, and training programs developed under the AI4Globe initiative.
- 3.1.2. Provide technical support and offer guidance to assist partner organizations in implementing these resources effectively.
- 3.1.3. Work collaboratively with partners to adapt and localize resources as necessary to meet specific needs and contexts.
- 3.1.4. Share the AI4Globe Visual Identity and guidelines with the Partner to ensure effective promotion of the project.
- 3.2 Nizhyn Mykola Gogol State University (NMGSU) is committed to:

- 3.2.1. Utilize the resources developed within the framework of the AI4Globe initiative within their own programs and initiatives aimed at enhancing AI literacy.
- 3.2.2. Actively promote the use of AI4Globe resources within their networks and key demographics of the initiative.
- 3.2.3. Provide feedback to BTU on the effectiveness and impact of the resources in their local context.

4. DURATION

4.1. This MoU shall be effective upon the date of signing and shall remain in effect for a period of 3 years, with the possibility of extension upon mutual agreement.

5. FUNDING

5.1. Each party expresses its intention to collaborate on fundraising efforts to cover any potential costs. For each specific activity, the parties may mutually agree on the associated costs on a case-by-case basis.



6. INTELLECTUAL PROPERTY

- 6.1. All intellectual property developed as part of the AI4Globe initiative remains the property of the initiative. Partners are granted a non-exclusive, non-transferable license to use the resources for the duration of this MoU.
- 6.2. In case of using the materials created within the framework of the 'AI4Globe' initiative for any other purpose, prior written consent from the initiative's managing entity (BTU) is required.

7. USE OF LOGOS

Both parties agree to use each other's logos in promotional materials and communications related to the AI4Globe initiative, in line with the branding guidelines provided by each party and as further regulated by the Terms and Conditions document.

8. CONFIDENTIALITY

8.1. Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this collaboration.

9. AMENDMENTS

9.1. This MoU may be amended or modified only by written agreement signed by both parties.

10. TERMINATION

10.1. Either party may terminate this MoU by providing written notice to the other party at least 6 months in advance.

11. GOVERNING LAW

11.1. This MoU shall be governed by and interpreted in accordance with the legislation of Georgia, unless the parties mutually agree on a different jurisdiction in the future.
